On the occasion of a national donation day conducted by the Liechtenstein Red Cross, the VP Bank Foundation participated by contributing CHF 25,000 toward aid to the earthquake victims in Haiti.

This past year, the board of trustees also supported efforts to network Liechtenstein-based charitable foundations even further on an international scale. At the same time, the Foundation was also committed to intensifying the exchange of experiences between Liechtenstein-based charitable foundations as well as the reinforced representation of their interests.

In both areas, notable progress and successes were achieved: Swiss Foundations, an internationally respected association of Swiss charitable foundations, amended its statutes to also enable membership for Liechtenstein charitable foundations.

The VP Bank Foundation joins this organization since 2011.

In December of 2010, the Association of Liechtenstein Charitable Foundations was established with the goal of promoting the

reputation and position of these local non-profit organizations. The chairman of VP Bank Foundation's board of trustees was elected to become the first chairman of this new foundation, in which the VP Bank Foundation is a charter member.

Applications and contact

Only comprehensive applications will be processed. At minimum, they must contain the following documentation:

- Accompanying letter outlining the key points of the project
- Project name and description; information on other project patrons; timetable
- Budget and financing plan; if possible, an annual report
- List of the other institutions that have been approached with requests for financing, as well as their statements of position
