Award-winning: VP Bank's annual report has again received several awards.

VP Bank Group's annual report won six international awards in 2023. These awards confirm the high quality of VP Bank's corporate communication and once again demonstrate the Bank's exceptional creativity.

Within the framework of the "Swiss Annual Report Rating", the annual report of VP Bank Group was ranked among the best 12 in the overall evaluation of 250 Swiss annual reports and took 9th place in the Value Reporting category. With a superb jury comprising design experts and financial professionals, this rating is the most important in Switzerland, and the largest of its kind.

VP Bank received further accolades at the prestigious ARC Awards in the USA. The online edition of the 2022 annual report was awarded with gold and the print edition received bronze, with VP Bank prevailing among 1,560 entries from 34 countries. The ARC Awards have been presented in the USA for 37 years and are the world's largest competition held exclusively for annual reports.

VP Bank also received a Gold Award for its print report and a Platinum Award for its online version at the 21st "Vision Awards" of the LACP, the League of American Communications Professionals in the USA, which attracted some 1,000 participants from 20 countries and scored 99 out of a possible 100 points.

Another Gold Award came from the 20th International Business Awards of the "Stevie Awards" from the USA for the 2022 print report. The winners of the Stevie Awards were selected from more than 3,700 nominations submitted by organisations from 61 countries.

The international "Galaxy Awards" honour outstanding achievements in marketing communications. In the annual report category, VP Bank's report received a Silver Award. A total of over 500 companies from 17 countries participated.

VP Bank Ltd was established in 1956 and, with around 1,000 employees, is one of the largest banks in Liechtenstein. VP Bank has an international presence, with locations in Vaduz, Zurich, Luxembourg, Singapore, Hong Kong and Road Town (British Virgin Islands). Its core competencies include the development of customised financial solutions for intermediaries and private persons. In addition, the Group has an international fund competence centre. As of 30 June 2023, client assets under management of VP Bank Group amounted to CHF 47.2 billion. VP Bank is listed on the SIX Swiss Exchange and has an "A-" rating from Standard & Poor's.
